### Privacy Policy | Lawnch Pty Ltd

This privacy policy (**Policy**) applies to all personal information, which has the meaning given to it in the *Privacy Act 1988* (Cth) (**Privacy Act**) (**Personal Information**) collected by Lawnch Pty Ltd ACN 670 738 637 and its affiliates (**Lawnch**, **we**, **us** or **our**) via the website located at <u>www.lawnch.com.au</u> (**Website**). Any capitalised terms referred to within this Policy that are not defined, have the meaning provided in the Lawnch Terms and Conditions, available on our Website.

This Policy will be reviewed and updated from time to time to take account of new laws, technologies, and changes to our operations and practices. A copy of the current version of this policy can be obtained by contacting our office at <u>info@lawnch.com.au</u>.

#### **1** Information collection

The types of information that we collect from you will depend on how you use our Website. We collect both Personal Information and non-personal information. In this Policy, Personal Information includes information or an opinion, whether true or not, about an identified individual or an individual who is reasonably identifiable as defined in the Privacy Act.

#### **1.1** Types of information we collect

We may collect Personal Information about:

- (a) our clients, business associates, potential clients, and their personnel;
- (b) other individuals while acting for our clients;
- (c) our suppliers and their employees;
- (d) our employees, partners, contractors, former employees, former partners, former contractors or prospective employees, contractors, or partners; and
- (e) other people who encounter a member of Lawnch.

#### 1.2 Personal Information

The Personal Information which we collect and hold about you may include:

- (a) personal details, including name, date of birth, contact details (including email addresses), occupation, company name, username, and password (as applicable);
- (b) financial and legal information;
- (c) employment history, education, and qualifications;
- (d) testimonials and feedback; and
- (e) any other information that assists us in conducting our business.

If the information does not disclose your identity, or enable your identity to be ascertained, it will in most cases not be classified as 'Personal Information' and will not be subject to this Policy.



We may also collect and process non-personal information provided to us by your browser when you visit our Website, for example, the website you came from, your location information, IP address, web browser and/or device type, and the time and date of access.

#### 2 How do we collect and protect your Personal Information

#### 2.1 Collect

We collect Personal Information in a variety of ways, including:

- (a) directly from you when you provide your details to us;
- (b) indirectly through various means such as emails, forms, face-to-face meetings, interviews, seminar registration and attendance, business cards, online enquiries and phone calls, social media platforms (such as articles and LinkedIn) and by using services on our Website; and
- (c) occasionally, from third parties. For example, we may use third parties to analyse traffic to our website, our blogs, and social media channels, which may involve the use of cookies to assist us in providing you with a better experience. In some circumstances, we may also collect Personal Information about an individual from a third party.

#### What are cookies?

Cookies are small data files used by websites for record-keeping purposes, and to enhance your online experience. While most websites automatically accept cookies, you can adjust your browser settings to limit the collection of cookies by us. If you choose to disable cookies, you may not be able to use certain features of our Website.

#### 2.2 Protect

We take reasonable steps to protect the security of Personal Information and protect Personal Information from misuse, loss, unauthorised access, modification, or disclosure. When we no longer require your Personal Information, we will take reasonable steps to destroy or de-identify it. However, most of the Personal Information that is stored in our client files and records will be kept for a minimum of seven (7) years to fulfill our record-keeping obligations.

#### 3 Who do we disclose your Personal Information to?

We may use, hold, and disclose your Personal Information for the primary purposes for which it was collected, including but not limited to:

- (a) conducting our business;
- (b) providing and marketing our products or services;
- (c) communicating with you to provide or promote our products or services;
- (d) purchasing goods or services;
- (e) assist us in managing, developing, and enhancing our services, including our Website;
- (f) considering the suitability of prospective employees;
- (g) complying with our legal obligations; and
- (h) administering, maintaining, supporting, and providing upgrades to our services and applications.
